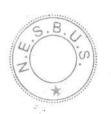

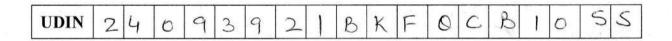

- 1. The Society is functioning from its Registered Office at House No.-18, Gali No.-19A, Maladband Entension, Badarpur, New Delhi-110014.
- 2. The society has developed a website for the society having web address as www.sehkaribachat.com
- 3. As explained to us the members are allowed to inspect the Books of Account and Independent Auditor's Report of the Society.
- 4. The society does not reconcile its accounts with the accounts of the members periodically as well as at the close of the co-op. year with general cash book. Hence we cannot comments on the balances. The management committee must ensure that the balances of members with respect to Loan Balances, Compulsory / Optional Deposit Balances, Admission Fees are reconciled on Bi-Monthly basis. This will ensure transparency and eliminate miss-balance of A/c Heads
- 5. The Society must reconciles its Bank Accounts with the Indian Overseas Saving Bank Account. on monthly basis. The balance as at 31st. March 2024 in the Indian Overseas Saving Bank A/s No. 150101000002070 was Rs. 47,76,384.57. The Bank Balance Certificate to this affect has been enclosed in the audit file. The Bank Interest Certificate provided by the bank on quarterly basis is also enclosed along with the audit file.
- **6.** The Society is keeping the records of relevant information and a part of the same have been provided to all the members for inspection as and when asked.
- 7. The Managing Committee consists of Nine (09) members & list for the same has been enclosed along with the audit report in audit file.
- 8. The Managing Committee Meeting must be held regularly on monthly basis. Only seven (07) Managing Committee Meeting was held during the financial year 2023 2024. The quorum was complete in the managing committee meeting. The proceeding of the meeting are recorded in the minutes books maintained by the society. Annual General Body Meeting (AGM) was held as on 6th Qctober 2023 during the financial year 2023-2024. No special General Body Meeting was held during the financial year 2023 2024.
- 9. Funds have been raised in accordance with the provisions of rule 65(1) of Delhi State Cooperative Rules, 2007 from members of the society.
- 10. The debt equity ratio of the society is nil because the society has not raised any funds from outside party. All funds are raised from the members.
- 11. Loan are given only to members and procedures are followed as per the norms. The Loan Agreement Form should be complete in all aspect with respect to signature of two authorized person. There must not be any smudging and over-writing in Loan Agreement Form with respect to loan amount applied for and loan amount sanctioned. The Re-Payment Installment Amount must be filled in the Loan Form. No authorized signatory were there in the loan agreement form authorizing the sanctioned & disbursed Loan amount from the period of 1st April 2023 to 31st July 2023.
- 12. The claims against members are being pursued properly. The amounts outstanding against the member are recovered from their salary on periodical basis as per the agreement signed.

13. The payment are made as per norms & vouchers are approved by the competent authority.

- 14. The MCL has been increased from Rs. 2,00,000 to Rs. 2,50,000 w.e.f 2019 .If there is any such change which may result into amendment of Bye-Laws then, the approval must be taken from the Office Of The Registrar Of Cooperative Society, New Delhi.** The MCL has been increased to Rs. 2,50,000, which is a violation of Rule 67 as mentioned under Chapter VI, Rule 67 of The Delhi Cooperative Society Rules 2007 A member can raise his share capital to a maximum of Rs. 20,000/- and that ensures that the maximum loan to be sanctioned to an individual member is 10 times of his share capital and that sums up-to a maximum of loan of Rs. 2,00,000 for each individual member even though The Maximum Credit Limit has been increased to Rs 2,50,000
- **15.** The decisions of Managing / General Body committee are been followed. The expenses incurred and paid by the society are approved in the managing committee meeting.
- 16. As reported and certified to us there is no unresolved dispute or case pending against the society. The No Dispute Certificate Authorized by The Management has been enclosed in the Audit File.
- 17. The Total strength of members as on 31.03.2024 was 933 in comparison to 950 as 31.03.2023. During the year 2023-2024, 70 members resigned from the society, 53 new members was enrolled in the society and No member died during this period. The applications for resignation by members and the application for enrollment as new members were available in the records. The resignation and admissions of members have been approved by the passing the resolution in the Managing Committee meetings. Separate list of new members enrolled and members who resigned during the period 2023-2024 are enclosed along with the Independent Auditor's Report file.
- **18.** As confirmed by the Managing Committee none of the office bearers suffers from the disqualification mentioned under Rule 54 of the Delhi State Cooperative Society Rules, 2007.
- 19. The society is not declaring & paying any amount as dividend to members. Instead of distributing such high value of gifts and violating Chapter VI, Rule 73 of The Delhi Cooperative Society Rules 2007, the Society should declare & pay the dividend subject to the maximum of 18% per annum of the paid-up share capital ONLY out of the net profit left, and ONLY after making a contribution towards reserve fund @ 25% of the net profit earned as per Section 53 of the Delhi Cooperative Society Act 2003 and transferring 2% of Net Profit To Cooperative Education Fund. During In the previous Audit Period of 2022-2023, no such amount was transferred from Net Profit to Reserve Fund which was a clear violation of Section 53 of the Delhi Cooperative Society Act 2003.
- 20. Budget must be prepared for incurring expenditure during the coming financial year. It is recommended that the budget prepared must be approved by the managing committee and recorded in the minutes of the Annual General Meeting. The standard variance between the Budgeted Figure & Actual expenditure incurred must be within 2 to 3 %
- 21. The society is not availing of any cash credit facility from anywhere.
- 22. The Book Of Accounts are maintained properly in the software developed by the society.
- 23. It is recommended that the society must also maintained Hard Copy Register relating to the transactions with members ie. Loan Transactions, Compulsory Deposits Transaction, All other transactions relating to members of The Society.
- 24. The Society possess and own Fixed Assets and depreciation has been charged and claimed by the society during the financial year 2023-2024 as per The Income Tax Act 1961(Amended).
- 25. Certificates for Maintenance Of Records, Documents and Cash In Hand have been obtained from the custodian & they are enclosed along with the Independent Auditor's Report.





- 26. The Share Money is being received from the members who are enrolled as a members of the society, but The Share Certificate to this Effect is NOT being issued since the inception of the Society. We as a statutory auditor of the society have suggested the management committee to issue a Share Certificate to the effect to each & every members of the society who has paid & subscribed for share capital of the society.
- 27. The Management Committee Of The Society is recommended & advised to comply with the provision of Chapter-. XVII of Income Tax Act 1959 (As Amended). with respect to TDS.
- 28. During the process of our audit it was found that the society was involved in some sort of business activity, like collecting money from non-members so as to provide them gifts later on when the gifts are being given to members at the annual general meeting. This type of business like activity by the Society Activity must be immediately stopped.
- 29. The provisioning of amount so as to disclosed in Financial Statement must be almost accurate with the exception of a variance of just 5 to 10 %. The provision made for interest on Compulsory deposit provided in FY 2022-2023 were too short with the accurate shortage of Rs.8.18,634.00/-
- **30.** We recommend the managing committee of the Society to make any payment with respect to GST only after having the valid and active Registered GSTIN of the party.
- 31. During the course of our audit procedure we observed and found that the software developed and maintained by the society has various loop holes which need to be rectified & corrected. This has been brought to the notice of managing committee & must be corrected & rectified within time before it is too late.
- **32.** The Society has amended its Seal (ie. Round Stamp) as The Parent Co. of the society objected to use it name "NHPC" in the name of the society. Hence The Round Stamp now just resemble "N.E.S.B. U.S". The society has applied to the RCS, New Delhi for its approval.
- 33. As per Chapter VI, Rule 73 of The Delhi Cooperative Society Rules 2007, Any Thrift & Credit Cooperative Society may give incentive/gift to its members, with the approval of the general body, not exceeding five per cent of its net profit subject to a maximum of three hundred rupees per member. This Chapter VI, Rule 73 of The Delhi Cooperative Society Rules 2007 has been violated during the current financial year 2023-2024 & hence we highly recommend to the management committee of the society that this rule 73 of Chapter VI must be complied with in the coming financial years. This violation of the Rule 73 of Chapter VI of The Delhi Cooperative Society Rules 2007 has been has been in continuity since long but was never reported in any of previous years Audit Report, if needed the matter must be resolved by communicating with The Registrar Of Cooperative Society, New Delhi & getting written approval from The Registrar Of Cooperative Society, New Delhi

AUDITOR'S OBSERVATIONS & COMMENTS ON THE ITEMS OF BALANCE SHEET:

1. SHARE CAPITAL

As on 31st March 2024 the balance under this head was Rs. 2,76,70,000.00 as compared to Rs. 1,89,90,000.00 as on 31st March 2023. During the year society has received Rs.1,01,00,000.00 as Share Capital Money. The society has refunded Rs.9,08,500.00 to its members and adjusted Rs. 5,11,500.00 as loan adjustment from its members out of share capital money.

2. RESERVE FUND

As on 31st March 2024 the balance under this head was Rs. 3,73,526.00 as compared to Rs. 3,73,526.00 as on 31.03.2023. During the year the society has incurred a loss (ie. Deficits) hence no amount has been transferred to Reserve Fund A/c. In the Previous Year 2022-2023 the society has earned a profit (ie Surplus) of Rs. 68,198.00, but no such amount (ie. 25% of the net profit) has been transferred to reserve fund account as per Section 53 of the Delhi Cooperative Society Act 2003. A clear violation of Section 53 of the Delhi Cooperative Society Act 2003.

3. DIVIDEND EQUALISATION FUND

As on 31st March 2024 the balance under this head was Rs. 30,547.00. The balance was same 30,547.00 as on 31st March 2023.No such amount was transferred to Dividend Equalisation Fund in the current FY 2023-2024.

4. PROVISION FOR BAD DEBTS

As on 31st March 2024 the balance under this head was Rs. 6,64,354.00. The balance was same 6,64,354.00 as on 31st March 2023. No sich provision for bad debts was made in the current FY 2023-2024.

5. COMPULSORY DEPOSIT

As on 31st March 2024 the balance under this head was Rs. 3,37,22,897.00 as compared to Rs. 3,11,62,624.00 as on 31st March 2023. During the year society has received Rs. 58,04,930.00 as compulsory deposits from members and refunded Rs. 22,86,268.00 to its members. The society also adjusted Rs. 9,58,389.00 as loan adjustment out of the compulsory deposits from its member.

6. OPTIONAL DEPOSIT

As on 31st March 2024 the balance under this head was Rs. 3,29,327.00 as compared to Rs. 3,37,318.00 as on 31st March 2023. During the year the Society has received Rs.1,12,400.00 as optional deposits from its members but refunded Rs. 1,13,302.00 to its Members. The society has also adjusted Rs. 7,089.00 as loan adjustment out of the optional deposits from its members.

7. CURRENT LIABAILITES COMPRISING OF

a) INTERNAL AUDIT FEES PAYABLE

Internal Audit Fees Payable as on 31st March 2024 was Rs. 17,700.00 as compared to Rs.70,800.00 as on 31st March 2023. During the current year audit period 2023-2024 out of the total outstanding of Rs. 70,800.00 of previous year 2022-2023 Rs. 53,100.00. was paid off and Rs. 17,700.00 is still outstanding & payable and disclosed separately as per Accounting Standard AS-1 issued by I.C.A.I.

b) COOPERATIVE EDUCATION FUND

For the FY 2023-2024 As the society has incurred a deficits (ie. Excess of Expenditure Over Income) the society has provided Rs. 933.00 for Cooperative Education Fund as per the rules of Coop. Society Act. In the Previous Year 2022-2023 contribution towards Cooperative Education Fund was Rs. 1364/- (ie 2% of Profit earned Rs. 68,198). The amount transferred to cooperative education fund in previous year 2022-2023 was paid on 08.04.2024 and hence, it is still showing payable as on 31st March 2024 summing upto Rs.2,296.57

e) INTEREST PAYABLE ON COMPULSORY DEPOSITS

Interest Payable on Compulsory Deposits as on 31st March 2024 was Rs. 12,15,630.00 as compared to Rs. 3,43,558.00 as on 31st March 2023. In the previous year 2022-2023 the provision for Interest Payable On Compulsory Deposit was made short by Rs. 8,18,634.00. This short provision was rectified in current financial year 2023-2024 and additional amount of Rs. 8,18,634.00 along with the current provision of Rs.12,15,630.00 was debited to income & expenditure account.

d) AMOUNT PAYABLE TO IN-ACTIVE / NON-TRACEABLE MEMBERS

Amount Payable To In-Active / Non-Traceable Members as on 31st March 2024 was Rs. 15,08,103.00 as compared to Rs. 3,02,330.00. in the previous year 2022-2023. During the year 2023-2024 an addition was made to this head of liability amounting to Rs. 12,25,773.00 and such in-active and no traceable members was paid off Rs. 20,000.00during the FY 2023-2024

e) AUDIT FEES PAYABLE

Audit Fees Payable as on 31st March 2024 was Rs. 81,227.00 as compared to Rs.1,66,100.00 as on 31st March 2023. During the current year audit period 2023-2024 out of the total outstanding of Rs.1,66,100.00 of previous year 2022-2023 Rs. 1,41,873.00 was paid off and Rs. 24,227.00 is still outstanding & payable for FY 2022-2023 and Rs. 57,000 for period under audit FY 2023-2024 and disclosed separately as per Accounting Standard AS-1 issued by I.C.A.I. During our audit procedure & verification for the audit period 2023-2024 we observed that Rs. 24,215.00 was paid in excess of what was claimed by the auditor as audit fees in the audit file submitted with the RCS out of the total outstanding and payable of Audit Fees of Rs.1,66,100.00 for previous year 2022-2023. The payment was made in this sequence Rs. 49,024.00 as on 4th October 2023 then Rs. 47,212.00 as on 7/11/2023 Rs. 45,637.00 as on 14th February 2024 and the last payment of Rs. 48,442.00 was made on 08th April 2024 summing up to Rs. 1,90,315.00 that is Rs. 24,215 in excess of what was claimed by the auditor and filed with the Registrar Of Cooperative Society, New Delhi. The management must ensure that this excess of payment must be refunded from the previous auditor as the previous auditor has neither claimed nor filed with the RCS and the audited books of accounts & records does not vouch and supports such excess amount paid in the name of audit fees.

f) OTHER EXPENSES PAYABLE

Other Expenses Payable as on 31st March 2024 was Rs. 54,000.00 as compared to Rs.54,000.00 as on 31st March 2023. In comparison there was no change on such other expenses payable amount.





g) SALARY EXPENSES PAYABLE

Salary Expenses Payable as on 31st March 2024 was NIL as compared to Rs.72,000.00 as on 31st March 2023. During the current year audit period 2023-2024 the total outstanding of Rs.72,000.00 of previous year 2022-2023 was paid off.

8. LOAN TO MEMBERS (Regular Loan)

As on 31st March 2024 the Balance under this head was Rs. 6,01,21,982.00 as compared to Rs. 5,21,91,864.00 as on 31st March 2023. During the current year society has disbursed & advanced loan of Rs. 6,11,19,960.00 to its members & recovered Rs. 5,30,63,668.00 from its members. The amount of Rs. 1,23,368.00 was adjusted with respect to loan disbursed to members in previous years. One member repaid excess amount then what was required for as repayment amounting to Rs.2,806.00 this excess repayment was refunded to the respective member during the current year under audit 2023-2024.

9. INTEREST ON REGULAR LOAN RECOVERRABLE FROM MEMBERS @ 7% pa.

As on 31st March 20224 the Balance under this head was Rs. 4,00,468.00 as compared to Rs. 3,21,308.00 as on 31st March 2023. During the current year 2023-20-24 society has charged interest on regular loan 0f Rs. 39,17,312.00 from its members & recovered Rs. 38,37,771.00 from its members. The amount of Rs.381.00 as Interest On Loan Recoverable from members were adjusted from compulsory deposits / optional deposits of those respective members. The balances are subject to confirmation from the members. The management of the society has been advised to issue Quarterly Balance Certificate to their members & receive their acknowledgement to this effect, so that the balances of The members with respect to Optional Deposits / Compulsory Deposits / Loan are always tallied & confirmed from the side of each & every members.

10. PRE- PAID EXPENSES

The balance under this head as on 31st March 2024 was Rs. 17,500.00.00 as compared to Rs. 17,500.00.00 as on 31st March 2023. In comparison there was no change on such amount as on 31st March 2024, but there was an addition of Rs. 2,806.00 to this head of account which was later on adjusted with excess re-payment of loan disbursed to one of the member. It is advised by us that this type of excess collection from members as loan / interest on such loan recovery must be stopped & given proper accounting treatment then & there as and when such incidents occurs.

11. REGULAR LOAN & INTEREST ON SUCH LOAN RECOVERABLE FROM INACTIVE / NON-TRACEABLE MEMBERS

The balance under this head as on 31st March 2024 was Rs. 7,67,833.00.00 as compared to Rs. 7,67,833.00.00 as on 31st March 2023. In comparison there was no change on such amount as on 31st March 2024

During the current year 2023-2024 the society has purchased a software & developed its website for the maintenance of its accounting records amounting to Rs. 94,400. Depreciation has been provided and claimed for Rs. 45,990.00 as per Income Tax Act 1961 (As Amended).In the previous year 2022-2023 the society has undercharged the depreciation amount by Rs.6,525 (ie Depreciation @ 10% on Rs. 21,750 instead of 40% on Rs. 21,750. In the previous year 2022-2023, the Fixed Assets consisted of a Laptop which depreciation rate is @40% as per Income Tax Act 1961 (As Amended).

14. The balance of option deposits, compulsory deposits, loan to members and Dividend Payable are subject to confirmation from the respective members. The management of the society has been advised us to issue Quarterly Balance Certificate to their members & receive their acknowledgement to this effect, so that the balances of the members with respect to Optional Deposits / Compulsory Deposits / Loan are always tallied & confirmed from of each & every members of the society.

<u>AUDITOR'S OBSERVATIONS & COMMENTS</u> ON THE ITEMS OF INCOME & EXPENDITURE A/c:

1. INTEREST RECEIVED ON SAVING BANK A/c

During 2023-2024 Society has received Rs. 19,715.00 as interest on Saving Bank A/cs, as compared Rs. 14,230.00 in 2022-2023. The society has one Saving Bank A/c in Indian Overseas Bank having A/c number - SB A/c. 150101000002070

2. INTEREST RECEIVED ON REGULAR LOAN (@ 7% pa)

The Society is charging interest as per rate approved by Managing Committee and Office of Registrar Cooperative Society. During the year 2023-2024 society received Rs. 39,17,312.00 as interest on Regular Loan as compared to Rs. 35,59,730.00 in the year 2022-2023.

3. ADMISSION FEES

During the year 2023-2024 Society has received Rs.53,000.00 as admission fees from new Members who enrolled themselves as a member of the society during the year 2023-2024 as compared to Rs. 77,000.00 in the year 2022-2023.

4. AMOUNT COLLECTED FROM MEMBERS FOR GIFTS

During the year 2023-2024 Society has collected Rs. 1,82,875.00 from non-members so as to provide them gifts all along with the members of the society at around the time of Annual General Meeting. This type of conduct seems to be some short to business activity, which should be immediately stopped. This management of the society has been made acquainted with this observation and has been suggested to stop such activity with immediate effect.

5. MISCELLANEOUS RECEIPTS

During the year 2023-2024 Society has credited Rs.3.00 as miscellaneous receipt as the society could not established from which head such excess was received. There was no such excess receipt in previous year 2022-2023.

6. INTEREST PAYABLE ON COMPULSORY DEPOSITS

During the year 2023-2024 Society has an expenditure of Rs. 20,34,264.00 as Interest Payable on Compulsory Deposit in addition to Rs. 11,62,192.00 paid through cheque / transferred through online banking transaction compared to Rs. 13,00,000.00 as interest payable on compulsory deposits in the previous year 2022-2023 in addition to Rs. 10,77,366. paid through cheque / transferred through onlinebanking transaction in 2022-2023. It was observed by the current managing committee that there was a short provisioning of Rs.8,18,634.00 with respect to interest payable on compulsory deposits in the FY 2022-2023 and because of that this additional provision of Rs. 8,18,634.00 was done in the current financial 2023-2024 to nullify its effects of short provision in FY 2022-2023.

7. SALARY EXPENSES TO OFFICE BEARER / ATTENDANT

During the year 2023-2024 Society has paid Rs. 14,400.00 as salary to its casual employee who handles Society file & office nitty-gritty work as compared to Rs.86,400.00 in the year 2022-2023.

8. ANNUAL GENERAL BODY MEETING EXPENSES

During the year 2023-2024 Society has incurred and paid Rs. 7,200.00 as Annual General Body Meeting Expenses as compared to NIL in the previous year 2022-2023.

9. ELECTION EXPENSES

During the year 2023-2024 Society has not incurred any amount as election expenses, as compared to Rs. 2,500.00 in the previous year 2022-2023

10. PROFESSIONAL EXPENSES (ie. Professional Fees)

During the year 2023-2024 Society has not incurred any amount as professional expenses, as compared to Rs. 10,000.00 in the previous year 2022-2023.

11. BOARD MEETING EXPENSES (ie. Managing Committee Meeting Expenses)

During the year 2023-2024 Society has incurred and paid Rs. 2,500.00 as Board Meeting Expenses as compared to Rs. 4,800.00 in the year 2022-2023.

12. DEPRECIATION

During the year 2023-202 society has charged & claimed Rs. 45,590.00 as depreciation on Fixed Assets as compared to Rs. 2,175.00 in the previous year 2022-2023. The depreciation was undercharged in previous year 2022-2023 by Rs. 6,525 resulting into appreciation of profit by the same amount.

13. BANK CHARGES

During the year 2023-2024 Society has incurred and paid Rs. 317.00 as bank charges as compared to Rs.1,487.00 in the previous year 2022-2023.

14. OFFICE RENT PAID

During the year 2023-2024 Society has not incurred any amount as office rent, as compared to Rs. 6,000.00 incurred and paid in the previous year 2022-2023. As explained by the managing committee this was due to the death of the land lord of the office building and the person in place of the land lord not claiming any amount for and as office rent during the FY 2023-2024.

15. AUDIT FEES PAYABLE

During the year 2023-2024 the society has incurred Rs. 57,000.00 for & as Audit Fees payable as compared to Rs. 42,000.00 in the previous year 2022-2023.

16. INTERNAL AUDIT FEES PAYABLE

During the year 2023-2024 Society has not incurred any amount as internal audit fees payable, as compared to Rs. 17,700.00 in the previous year 2022-2023.

17. MISCELLANEOUS EXPENDITURE

During the year 2023-2024 Society has not incurred any amount as miscellaneous expenditure, as compared to Rs 25,850.00 in the previous year 2022-2023

18. FESTIVAL GIFTS EXPENSES (Diwali Gift Distribution)

During the year 2023-2024 Society has incurred & paid Rs. 23,72,630.00 as festival gifts expenses on distributing diwali gifts to members, as compared to Rs. 20,43,000.00 in the year 2022-2023. As per Chapter–VI, Rule 73 of The Delhi Cooperative Society Rules 2007, Any cooperative society that pays dividend may give incentive/gift to its members, with the approval of the general body, not exceeding five per cent of its net profit subject to a maximum of three hundred rupees per member. The society has violated Rule 73 under Chapter VI of The Delhi Cooperative Society Rules 2007. The Society must comply with the Rule -73 as under Chapter VI of The Delhi Cooperative Society Rules 2007. During the course of audit procedure we also observed that the society collects money from non-members of the society and give them the same gifts along with regular members of the society. This short of business dealing activities must be immediately stopped as the society is a association of person who comes together to achieve a common purpose or engage in a joint business activities for the mutual benefits of the members only.

19. SOFTWARE DEVELOPMENT EXPENSES

During the year 2023-2024 Society has not incurred any amount as software development expenses, as compared to Rs. 23,600.00 in the previous year 2022-2023. In the previous year 2022-2023, it was also a wrong accounting treatment to consider the software development expenses as revenue expenditure instead of capital expenses (CAPEX).

20. SOFTWARE MAINTENANCE EXPENSES

During the year 2023-2024 Society has not incurred any amount as software maintenance expenses, as compared to Rs. 24,000.00 in the previous year 2022-2023. It was very surprising to note that the software development charges/expenditure was less than the software maintenance expenses.

- 1. It is highly recommended to the management of the society, that as the society consists of more than 900 members and transaction is huge and large, a full time employee having proper accounting knowledge must be recruited and employed with the society, so that there is a very less chance of error in accounting treatment, because a huge amount is involved in day to day transactions and any wrong accounting treatment would lead to chaos and misrepresentation. The person who is employed for maintaining book of records and accounts of the society& the society's day to day activities must be sent for Cooperative Training to acquire Diploma in Cooperative Management from the Delhi State Cooperative Training Centre, New Delhi.
- 2. The managing committee is advised, to give proper instruction to the competent authority to make sure that, there is no over-writing / smudging on loan amount applied for and the loan amount sanctioned in Loan Application Form. It is suggested that, if any rectification is needed then A Fresh Loan Application Form must be issued and detail must be filled as required and must be authorized by the respective personnel. It must also be taken care that the amount mentioned in loan applied-for and loan-granted is same in to-to.
- 3. When fresh loans are sanctioned to members it must be given only after settling the old loans, if any, preferably after a sufficient gap. The monthly installment of loan to be repaid must be mentioned in each Loan Application Form and Loan Sanctioned Form, and not merely where it is specifically mentioned by the borrowers of loan..
- 4. As per Chapter VI, Rule 73 of The Delhi Cooperative Society Rules 2007, Any Cooperative Society that pays dividend may give incentive/gift to its members, with the approval of the general body, not exceeding five per cent of its net profit subject to a maximum of three hundred rupees per member. This Chapter VI, Rule 73 of The Delhi Cooperative Society Rules 2007 has been violated during the current financial year 2022-2023 & hence we highly recommend to the management committee of the society that this rule 73 of Chapter –VI must be complied with in the coming financial years. This matter has been highlighted & reported in previous years too, if needed the matter must be resolved by communicating with The Registrar Of Cooperative Society, New Delhi & getting written approval from The Registrar Of Cooperative Society, New Delhi
- 5. The society has increased its maximum credit limit from Rs. 2,00,000 to Rs. 2,50,000. This increase is 125 % of its current sanctioned maximum credit limit. As per Rule 67 as mentioned under Chapter VI, Rule 67 of The Delhi Cooperative Society Rules 2007 A member can raise his share capital to a maximum of Rs. 20,000/- and that ensures that the maximum loan to be sanctioned to an individual member is 10 times of his share capital and that sums up-to a maximum of loan of Rs. 2,00,000 for each individual member even though The Maximum Credit Limit(MCL) has been increased to Rs. 2,50,000 & this is a clear violation of Rule as mentioned under Chapter VI, (ie. Rule 67 of The Delhi Cooperative Society Rules 2007)
- 6. Any amendment in bye-laws of the society (ie. Increase in share capital, or increase in MCL or providing for more value of gifts then what (The Delhi Cooperative Society Rules 2007 / Delhi State Cooperative Act 2003 provide for) must be 1st approved by THE RCS (The Registrar Of Cooperative Society, New Delhi) then only such amendment will have any legality or else it is just violation of Rules mentioned in The Delhi Cooperative Society Rules 2007 and the sections mentioned in Delhi State Cooperative Act 2003 and Certificate to this effect must be obtained from the current Statutory Auditor.
- 7. The society is NOT filing its ITR since long. This is a matter of great concern and this has been brought to the notice of the managing committee of the society.



- 8. While making payment the management must ensure that they have complied with the provision of Chapter-. XVII of Income Tax Act 1959 (As Amended).with respect to TDS
- 9. When the money is collected from members with respect to Loan Recovery, contribution towards compulsory deposits, share money and admission fees then the person handling the accounts departments and making entry in the software, he must ensure that the amount received for the specific purpose is recorded in that specific head of accounts.
- 10. We have recommend the managing committee of the Society to make any payment with respect to GST only after having the valid and active Registered GSTIN of the respective party.
- 11. Many of the members balances for the previous year as on 31.03.2023 were in negative which were rectified & corrected in the month of July & August 2023. These rectification must be approved in the Annual General Meeting to be held in October 2024 or it must be approved by passing a resolution in A Special General Body Meeting as it a matter of great concern and the certificate to this effect must be issued to all the concerned members & get their acceptance and acknowledgement for their respective balances.
- 12. During the course of our audit procedure we observed that there were some loop holes in the software maintained for accounting and maintaining of records. These loop-holes in the software must be addressed by the managing committee so that the software is made robust and free of such loop-holes.
- 13. The software which is being used for recording the transaction of the society on day-to-day basis must be free from any loop-holes so that only correct data is being processed and correct and accurate out put is generated. After so many re-run of processing of data, the software still shows one of the member named Shri Madan Pal (Membership Code-120587) having (Re 1) Negative. Loan Balance. This should not be the case as this member must have cleared all his loan balance and may have been retired/resigned/suspended/dead. In the same way one ,member named Shri Arun Kumar Jain (Membership No.-120552) has only a balance of Rs. 500/- as Compulsory Deposits. This member too have cleared all his loan balance and may have been retired/resigned /suspended/dead. This type of error in processing of data by the software must be avoided and the management must ensure that error free processing of data is done by the software developed & purchased and as an output only crystal clear information is provided by the software.
- 14. The Society has amended its Seal (ie. Round Stamp) as The Parent Co. of the society objected to use it name "NHPC" in the name of the society. So, The Round Stamp now just resemble "N.E.S.B.U.S". The society has applied to the RCS, New Delhi for its approval. The management committee must ensure that any amendment made by passing a resolution is approved by The Registrar Of Cooperative Society, New Delhi.
